EuSEM ANNUAL SUBSCRIPTION 2009

I am writing to inform you that annual subscriptions for 2009 are due by 1st January 2009. Unlike in previous years members who have previously submitted credit card information will not have their subscriptions automatically debited after January 1st. All renewing members will need to arrange payment via the methods outlined below.

This is due to changes in UK banking regulations where card-not-present transactions must be processed using the card security code (also known as CSC, CVV or CVV2 number). Also, the society is not allowed to maintain records of card security codes in any format once payment is approved.

Please accept our apologies for any inconvenience this may cause. EuSEM is developing systems to facilitate subscription renewals and will keep members informed of progress.

Annual subscriptions to EuSEM will remain at the same rate since 2001 (Please see overleaf).

Payment Methods
